- New standalone public toilets at: Holmesglen Reserve, Galbally Reserve, Napier Par Reserve, Electra Reserve, Glen Waverly North Reserve, Waverly Road Basin (abutting Melbourne Water Blackburn Road retarding basin), Fairway Reserve, Melissa Street Reserve (abutting Melbourne Water near Huntingdale Road), Davies Reserve, Lum Reserve, Batesford Reserve
- New public toilet within new pavilion at: Mulgrave Reserve, Gardiners Reserve, Carlson Reserve, Fregon Reserve, Ashwood Reserve, Meade Reserve
- Open exiting toilets to the public at: Gardiners Reserve, Mount Waverly Reserve, Southern Reserve, Fregon Reserve, Ashwood Reserve, WA Scammell Reserve, Lum Reserve, Batesford Reserve, Federal Reserve, Carlson Reserve, Glen Waverly North Reserve\*, Davies Reserve\*, Gladeswood Reserve\*

\* The existing public toilet facilities at these locations have potential for public access. However, due to their current condition and site constraints, refurbishment of the facilities may be required prior to opening the facilities to the public, particularly where they don't meet the requirement of the Disability Discrimination Act.
