INTRODUCTION

Council has received feedback from residents and community groups in Ashwood and Chadstone that they are keen to contribute more to community consultation but can experience difficulty accessing consultations at times, particularly via online options. Residents living in local social and public housing have been identified as particularly at risk of disengagement from Council consultations.

Council has been progressing a number of major projects of importance to the Ashwood and Chadstone communities including the proposed social housing project at 65A Power Avenue and the walking and cycling connections between Mount Waverley Station and Jordanville Station.

Through our Placemaking team, with support from Communications, Council will investigate other options to understand and promote engagement with these communities, including pop-up inperson sessions for significant consultations.

RELEVANCE TO WORK ALREADY UNDERTAKEN BY OFFICERS OR COMMITTEES

The Neighbourhood and Placing Making team has a dedicated Place Maker who engages with key stakeholders such as the Ashwood and Chadstone Public Tenants Group, Ashwood Partnership Group and Amaroo Neighbourhood House and Power Neighbourhood House.

Regular meetings take place with these stakeholders to ensure the community is informed of Council programs and services and community concerns are passed onto Council.

Officers will further engage with the relevant stakeholders, with the support of Communications, to map out a preferred engagement model.

FURTHER CONSIDERATIONS

Gaining community trust and confidence takes time and resources and changes can appear to be slow. Although existing channels are in place for these residents to contribute to consultation and engagement activities, there is always an opportunity to strengthen these channels and tailor them to the needs of stakeholders.
