LGBTIQ+ Advisory Committee

Purpose

Council endorsed the LGBTIQ+ Advisory Committee at the 15 December 2020 Council meeting as part of its ongoing commitment to better recognise, represent and connecting with members of Monash's lesbian, gay, bisexual, trans and gender diverse, intersex, queer/questioning and asexual communities (LGBTIQ+). The plus (+) sign serves to signify and acknowledge the inexhaustive nature of this collection of terms, and the fact that language can and does evolve to find new terms for describing the diverse ways in which people can experience gender, sexuality, and sex characteristics.

The aim of this Committee is to provide Council with advice on strengthening the representation and inclusion of people who identify as LGBTIQ+ within the Monash community and to contribute to the development and implementation of Council's LGBTIQ+ Action Plan.

Committee Responsibilities

- Advocate for equality and inclusion for the LGBTIQ+ communities in Monash.
- Provide feedback and advice to Council on the impact of its policies, plans and services on the LGBTIQ+ communities.
- Assists and provides advice to Council on the implementation of the LGBTIQ+ Action Plan.
- Consider funding and other opportunities as they arise.
- Support Council to engage and consult with local LGBTIQ+ groups and communities.
- Provide advice to Council on issues and barriers that affect people who identify as LGBTIQ+.
- Contribute to the promotion of Council and community collaborations that support and promote the inclusion of people who identify as LGBTIQ+.

Committee Composition

The LGBTIQ+ Advisory Committee membership consists of:

- Up to three (3) Councillors
- Fourteen (14) community representatives including:

- Up to twelve (12) community members living, working and/or studying in Monash representing the diversity of the Monash LGBTIQ+ communities and allies.
- Up to four (4) community organisations, agencies and service providers who have a focus on providing services to the Monash LGBTIQ+ communities.

All LGBTIQ+ Advisory Committee positions are voluntary positions. Monash City Council employees are ineligible to sit on the Committee.

From time to time, the LGBTIQ+ Advisory Committee may establish working groups and invite additional members, including Council officers, if it is considered that additional skills and experience would benefit a specific project or add value to the general performance of the Committee.

Junior Advisory Group (JAG)

Junior Advisory Group (JAG)

Purpose

Monash Council is committed to being a Child and Young People Friendly City (CYPFC) and has endorsed the *Victorian Charter for Child Friendly Cities and Communities*.

The Junior Advisory Group (JAG) plays a vital role in amplifying the voices of children and young people in Council matters. It reflects Council's commitment to fostering inclusion and providing meaningful opportunities for young residents to engage in civic life and contribute to decision-making.

The JAG also supports Council's obligations under the *Local Government Act 2020* and aligns with key strategic directions, including the *Imagine Monash in 2040 Community Vision* and the *Council Plan 2025–2029*.

The Junior Advisory Group

- Connects children with Local Government and Councillors.
- Enables local primary school students in Grades 3–8 (ages 8–14) to voice concerns or questions.
- Provides opportunities for children to be consulted on Council business and matters that affect them.
- Offers a forum for children to participate as active citizens.

Composition

The JAG comprises students from Monash primary schools and the Mayor (or Deputy Mayor).

In 2025, Council appointed Mayor Paul Klisaris and, following the Mayoral changeover, Mayor Stuart James to represent Monash Council at JAG meetings.

The JAG is coordinated and supported by Council's Child and Young People Engagement Officer.

Frequency of Meetings

Traditionally, the JAG meets twice per year, in the second and fourth quarters.

2025 Activities

The first JAG meeting for 2025 was held on Wednesday, 4 June at the Monash Civic Centre in Glen Waverley. Mayor Paul Klisaris attended the session, which brought together 23 students from five Monash primary schools, along with their teachers. Students participated in a consultation to inform Council's *Children, Youth and Family Services Infrastructure Plan* and engaged in a question-and-answer session with the Mayor.

The planned November JAG meeting did not proceed due to limited school availability and the Mayoral changeover period.

Additional to the scheduled JAG meetings for 2026, a session was held with students to 'close the loop' on a previously held consultation in 2024 on the *Health and Wellbeing Plan*.

Future Direction

On 25 November 2025, Council resolved to transition the Monash Junior Advisory Group (JAG) from a formal advisory committee to a program within the Children and Young People Engagement portfolio, reflecting its primary role in civic learning, inclusion and child and youth participation. This change supports a more flexible, age-appropriate engagement model, with the Mayor of the day representing Council (and the Deputy Mayor as proxy), while continuing to value children's voices in the organisation's engagement practice.

The Junior Advisory Group will continue in 2026. A review of meeting dates will be undertaken, with the aim of scheduling sessions earlier in the year to better support school participation, avoiding conflicts with Council commitments and reducing end-of-year pressures.

Multicultural Advisory Committee

Purpose

The aim of the Multicultural Advisory Committee (MAC) is to provide Council with advice on a range of multicultural issues.

Committee Responsibilities

- Provide feedback and advice to Council on its policies, plans and services that impact CALD communities.
- Consider and provide advice on key Government initiatives, programs and reviews.
- Advocate on behalf of CALD communities.
- Consider funding and other opportunities as they may arise.
- Assist Council to promote the benefits of cultural diversity within the Monash municipality and beyond.

- Provide advice to Council with its communication, engagement and consultation with CALD communities.

Committee Composition

The Multicultural Advisory Committee membership will consist of:

- Up to three (3) Councillors.
- Fourteen (14) community representatives including:
 - Up to twelve (12) community members living or working in Monash,
 - Up to four (4) community organisations, agencies and service providers that have a focus on provision of services to CALD communities in Monash.

Achievements for 2025

In 2025, the MYC undertook the following:

- A youth 'Shout Out' training session delivered by Centre for Multicultural Youth, the speaker covered topic including cultural diversity, identity and leadership.
- Provided feedback to Victorian Governments, Legislative Assembly Economy and Infrastructure Committee, sharing their experiences relating to education, training and employment.
- Provided advice and feedback on the Health and Wellbeing Plan, Community Vision and Council Plan.
- Provided written feedback to Shape Monash on the proposed new civic precinct for Glen Waverley.
- Provided feedback Senior Project Manager, Suburban Rail Loop on disruptions to public transport impacting Monash young people.
- Advocated for improved Road Safety Around Monash Schools.
- To advocate for Kallan Lodge libraries at Monash Hospital and/or headspace Syndal in 2026. Kallan Lodge library establishes and maintains literature and music libraries for young people to access within Australia's mental health facilities.

Members for endorsement or reappointment

During 2025 MYC received ten resignations. These resignations predominately related to committee members increasing work, school, or university commitments. These members have been active and valuable representatives through their involvement in and contribution to MYC in 2025: Ms Aditi Sanghi, Ms Osandi Liyanage, Ms Sanjoli Patra, Ms Yixi Qin, Ms Lavanya Sharma, Ms Saathvika Arun, Mr Tyson Husson, Ms Jill Xu, Mr Heerag Khan and Mr Arjun Kapoor.

To fill vacancies, the MYC continually seeks membership from young people aged 15 – 25 who live, go to school, or work in the City of Monash. In 2025 Ms Natalie Loo, Ms Bree Wang, Ms Chloe Boucherat, Ms Raghad Yousif, Mr Gaji Rajapaksh, Ms Nika Sahebi, Ms Kety Li, Ms Chloe Jolme, Mr Neerav Jain, Mr Able Joseph, Ms Ana Donnellon, Ms Angela Huang and Ms Shivika Verma were successful in their application for MYC.

The Committee seeks the endorsement of the appointment of Charlie Paterson, Shreya Kalani, Celeste Sharma, Adhyen Kathpal and Kiley Chen to the 2026 Monash Youth Committee.

As a result of the resignations and appointments in this report, the group will have 25 endorsed members of young people. Currently, there are no places available for a new MYC member in 2026.

Clayton Activity Centre Committee

Purpose

The purpose of the Clayton Activity Centre Committee is to provide high level advice and input into major projects and Council strategies in Clayton, including implications for Council arising from the Suburban Rail Loop project in Clayton and near Monash University, and be a conduit for consultation and engagement between Council and the Clayton Traders Association, local residents and other traders and key stakeholders in Clayton.

The Committee will assist Council to make the most of current and future opportunities for improving the amenity and liveability of Clayton as a place to work, rest, study and play. It is important for Council as a landowner and the local planning authority to take a coordinated approach and ensure that the Clayton Activity Centre can continue to grow and be vibrant.

Committee Composition

In 2025, Councillor Paul Klisaris and Councillor Cameron Little (who acted as Chair) served as the Council representatives on the Clayton Activity Centre Committee.

Objectives

The committee looks at matters such as:

- SRL Precinct Planning and impacts from SRL works
- Better amenity in the town centre and improvements
- Trucks on Clayton Road and parking matters
- Parking and traffic issues in the Activity Centre

Frequency of Meeting

The Committee was scheduled to meet every two months, or as required. Meetings alternated between in-person sessions held in Clayton and online formats. In 2025, the Committee convened once, on 31 October.

Glen Waverley Activity Centre Committee

Purpose

The purpose of the Glen Waverley Activity Centre Committee is to provide high level advice, direction and input into major Council and State Government projects and strategic policy initiatives for the Glen Waverley Activity Centre (GWAC).

The key areas of focus for the preceding 12 months include:

- The sale of Central Car Park
- Landscape design of the Council Reserve adjacent to the Central Car Park land that was sold
- Suburban Rail Loop Project including road closures, traffic management and SRLA's precinct plan
- The Kingsway Rejuvenation Project
- The Glen Waverley Civic Precinct Project
- Engagement with the Glen Waverley Traders Association

Committee Composition

In 2025, Councillor Paul Klisaris, Councillor Nicky Luo, Councillor Rebecca Paterson and Councillor Geoff Lake (who acted as Chair) served as the Council representatives on the Glen Waverley Activity Centre Committee.

Objectives

The objectives of the GWAC Committee are:

- Provide input and advice to Council on opportunities, Council and State Government driven strategic development issues and major projects in the Activity Centre.
- Actively support and assist Council's consultation with, engagement and advocacy to the State Government, relevant stakeholders and the broader community in relation to the GWAC.
- Assist with shaping and encouraging a reinvigorated Kingsway streetscape which prioritises pedestrians, outdoor dining and other activity over cars.
- Recommend to Council appropriate projects or development opportunities for the GWAC.
- Assist Council in determining priorities and strategic directions for the Activity Centre.

Frequency of Meeting

The Committee meets on a monthly basis or as needed. In 2025, the Committee met on five occasions: 4 February, 11 March, 6 May, 30 September and 9 December.

Oakleigh Activity Centre Steering Committee

Purpose

The purpose of the Oakleigh Activity Centre Steering Committee is to provide high level advice and input into major Council and State Government projects for the Oakleigh Activity Centre and be a conduit for consultation and engagement between Council and the Oakleigh Business and Traders Association, local residents and other traders and key stakeholders in Oakleigh.

The Committee will assist Council to make the most of current and future opportunities for improving the amenity and liveability of Oakleigh as a place to work, rest, study and play. It is important for Council as a landowner and the local planning authority to take a coordinated approach and ensure that the Oakleigh Activity Centre can continue to grow and be vibrant.

Committee Composition

In 2025, Councillor Paul Klisaris, Councillor Josh Fergeus and Councillor Stuart James (who acted as Chair) served as the Council representatives on the Oakleigh Activity Centre Steering Committee.

Objectives

The key objectives of focus for the preceding 12 months include:

- Huntingdale Streetscape Plan

The Committee was scheduled to meet online every two months, or as required. In 2025 the Committee convened once on 24 February.
