#### 4.1 TERM OF MAYOR AND DEPUTY MAYOR

#### **RECOMENDATION**

That Council, in accordance with the requirements of

- 1. Section 20(A) of the Local Government Act 2020, establish the office of the Deputy Mayor.
- 2. Section 26(3) of the *Local Government Act 2020*, Council elect the Mayor and Deputy Mayor for a 1 year term.

#### **INTRODUCTION**

Section 26(3) of the *Local Government Act 2020* (the Act) requires Council to determine by resolution whether the Mayor and Deputy Mayor is to be elected for a 1 year or a 2 year term. This must be done before the election of the Mayor takes place. Section 26 of the Act also applies to the election of a Deputy Mayor. This report has been submitted for Council's consideration by the Chief Executive Officer in accordance with the requirements of the Governance Rules.

#### **COUNCIL PLAN STRATEGIC OBJECTIVES**

## A council with good governance, strong leadership and community involvement in decision making

A Council that provides governance and leadership for the benefit of our community through community engagement, advocacy, decision making and action.

#### **BACKGROUND**

The Act requires Council to consider the Mayoral term before the election of the Mayor takes place. This requirement also extends to the term of the Deputy Mayor. Council has traditionally elected the Mayor and Deputy Mayor for a 1 year term.

#### **DISCUSSION**

Section 26(3) of the Act states:

"Before the election of the Mayor, a Council, other than the Greater Geelong City Council, must determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term."

It should be noted that in accordance with section 27(2) of the Act, section 26 applies to the election of a Deputy Mayor as if any reference in that section to the Mayor was a reference to the Deputy Mayor. This paper's recommendation for a 1 year term for the Mayor and Deputy Mayor has been prepared to reflect custom and practice. The Act requires the next election of the Mayor and Deputy Mayor to be held on a day to be determined by Council that is as close to the end of the approved term as is reasonably practicable.

#### 5 ELECTION OF THE MAYOR

#### 5.1 ELECTION OF THE MAYOR

#### INTRODUCTION

The election of the Mayor is carried out in accordance with the *Local Government Act 2020* (the Act) and the Governance Rules.

#### **BACKGROUND**

Each year the Councillors elect a Mayor in accordance with the Act. The election is carried out in accordance with the relevant sections of the Act and the Governance Rules.

#### **DISCUSSION**

The relevant sections of the Act are:

- Section 25(1) states that the Councillors must elect a Mayor of the Council.
- Section 25(2) states that any Councillor is eligible for election or re-election to the office of Mayor.
- Section 25(3) states that the Chief Executive Officer must chair the Election of the Mayor.
- Section 25(4) states that the Mayor must be elected by an absolute majority of Councillors.
- Section 25(5) states that if an absolute majority of the Councillors cannot be obtained at the meeting, the Council may resolve to conduct a new election at a later specified date.

The relevant parts of the Governance Rules are:

- Rule 43(a) which provides for the facilitation of the election of the Mayor in accordance with the Act.
- Rule 43(b) which states that the election for the Mayor must be carried out by show of hands.
- Rule 43(d) which provides for the procedure for the election of the Mayor.

Accordingly, the Chief Executive Officer will chair the Meeting and conduct the process for the election of the Mayor in accordance with the Act and the Governance Rules.

Once the election has taken place, the new Mayor will take the chair for the remainder of the Meeting and to conduct the election of the Deputy Mayor.

#### **CONCLUSION**

That Council elects a Mayor in line with the requirements under the Local Government Act 2020.

The relevant sections of the Act are:

- Section 27(1) states that section 25, other than subsection (3)(a) applies to the election of a
  Deputy Mayor as if any reference in that section to the Mayor was a reference to the
  Deputy Mayor.
- Section 27(2) states that section 26 applies to the election of a Deputy Mayor as if any reference in that section to the Mayor was a reference to the Deputy Mayor.

The relevant parts of the Governance Rules are:

• Rule 43(f)(i) which provides for the facilitation of the election of the Deputy Mayor in accordance with the Act.

- Rule 43(b) which states that the election for the (Deputy) Mayor must be carried out by show of hands.
- Rule 43(f) provides for the procedure for the election of the (Deputy) Mayor.

The Mayor will conduct the election of the Deputy Mayor.

#### **CONCLUSION**

That Council elects a Deputy Mayor in line with the requirements under the *Local Government Act* 2020.
