
Waverley Women’s Sports Precinct Plan Draft Report Community Feedback Summary

The Draft Waverley Women’s Sports Precinct Plan was placed on public exhibition from 28th August – 12th October, 2020. Two hundred and fifty-four (254) responses were received via the on-line feedback survey. The following section provides a summary of key findings.

Respondent User Type – What best describes you?


The results indicate 72% of respondents participate in sporting activities – including as players, officials, administrators or spectators. 19% identified as local residents and a further 7% as recreational users of the reserve.

The usage profile (i.e. 72% sport based) reflects the importance of this venue as a regional sporting destination within the City of Monash.



Respondent Postcode:


The majority of respondents were from Glen Waverley & Wheelers Hill (40%), however the results support a broad catchment for the Precinct.



Level of Support for Key Directions:

Almost three quarters (73%) of respondents indicated support for the key directions outlined in the Draft Precinct Plan.

It is noteworthy to acknowledge that Council became aware of a letterbox drop by a local resident during the consultation period that resulted in a small surge in negative responses coinciding with distribution. Whilst all responses have been assessed on their individual merits, it remains unclear if the information circulated accurately represented the detail of the Draft Precinct Plan.




Level of support for key directions

(‘Overall, are you supportive of the key directions detailed in the draft Precinct Plan??’)

Summary of Themes arising from Positive/Supportive Feedback:

Open ended questions were assessed to identify common positive/supportive themes mentioned in feedback. Most responses indicated more than one element; however, the *main* comments are reflected in the graph below. It is acknowledged that there is considerable cross-over between themes. For example, the majority of responses indicated support for general improvements to the Precinct – i.e. all packages of works – this was classified as Improved Amenities (i.e. overall amenity improvements within the Precinct – not a specific reference to toilet/amenities, however this is included).

Where specific elements were identified as the prime response these have been identified, for example Sporting Facility improvements (21%); Safety (16%), Lighting (11%), Car Parking/Paths (5%) – the latter three elements having considerable cross over in responses.



Summary of themes arising from positive/supportive feedback


Summary of Themes arising from Negative /Unsupportive Feedback:

As per above, open ended questions were assessed to identify common negative/unsupportive themes mentioned in feedback. Most responses indicated more than one element; however, the *main* comments are reflected in the graph below.

A lack of Sporting Diversity (41%) reflects comments suggesting the Precinct should cater for more sports than just Softball and Netball. In particular opportunities for basketball and tennis were commonly raised, even as casual use facilities (e.g. basketball rings and hit-up wall). The Precinct has a deliberate focus on Netball and Softball as a State significant venue. However, multi-use is encouraged, including the netball courts and playing fields. At least one of the two proposed new outdoor netball courts will be multi-use (i.e. including basketball rings). These will be adjacent to the proposed new amenities building and play/fitness hub. No further changes to the plan are proposed.

Twenty-six (26%) of responses were concerned that improvements to the Precinct would lead to increased use which would have detrimental impacts on local amenity. This can be coupled with respondents who indicated Increased Traffic (18%) as their main concern. The Precinct Plan identifies opportunities to maximise effective car parking and traffic management within the study area, however a broader review of traffic management across the entire Jells Park precinct may need to be considered in future planning (Council and VicRoads) - this is already identified as Package 2c: "Broader traffic investigations (encompassing golf course and shared creek trail) to be undertaken to consider vehicle access & circulation, a potential Jells Road pedestrian crossing and drop off zones", therefore no changes are proposed to the Plan.

Remaining feedback were concerned about impacts on trees (9%), perceived loss of open space (3%) and extent of built form/infrastructure proposed (3%).



Summary of themes arising from negative/unsupportive feedback


Changes Based on Feedback:

Based on the feedback received and high level of support for the existing plan, limited changes are proposed to the Final Precinct Plan. Ninety-three (93%) of responses require no changes to the Plan (reflecting the high levels of support). Two (2%) can be addressed via minor text changes, additions or references to future planning work (i.e. for consideration in detailed designs for each package) and 5% will result in minor design changes to the Plan.

The minor design changes include:

- Review site plans to identify a possible additional hard-surface warm-up space/s for netball (this does not need to be a dedicated space) – access to adequate warm-up space is a major issue for netballers.
- Review plans to ensure existing water fountain near batting cage is captured, as well as identify proposed new locations to service softball fields.
- Review plans to ensure locations of seating/shade are identified around diamonds.
- Review recommendation for lighting to Diamond 1 and cost allowance (i.e. upgrade as required).

The accompanying Excel spreadsheet provides a detailed summary of all individual submissions, review comments and indication of changes to the Plans.
