

4.1 TENDER FOR SMALL PLANT, MACHINERY AND RELATED PRODUCTS

RECOMMENDATION*That Council:*

1. *Appoints the following suppliers to a panel for the provision of Small Plant, Machinery and Related Products for a three (3) year term with options for extension of two (2) x one (1) year periods for the schedule of rates submitted (Estimated annual expenditure of \$300,000 GST inclusive and a total estimated contract value of \$1,500,000:*

3. *Notes that initial contract term ends 31 August 2021 and the contract has two extension options of one year each and authorises the Chief Executive Officer to approve extension options subject to Procurement Australia extending the contract and satisfactory performance.*

INTRODUCTION

Procurement Australia has conducted a tender for provision of Small Plant, Machinery and Related Products. Council currently utilise an existing Procurement Australia contract for the provision of small plant and machinery.

BACKGROUND

In April 2018 Council advised Procurement Australia of the intention to appoint Procurement Australia as Agent to tender for the provision of small plant, machinery and related products. Participation in the tender process did not oblige Council to accept the outcome.

NOTIFICATION

A Public Notice was not required because the supplier has been selected from the existing Procurement Australia Contract Number 21085-0905 – Small Plant Machinery and Related Products as allowed under the Local Government Act, Section 186, Part 5, in accordance with arrangements approved by the Minister.

All members of the evaluation panel signed Conflict of Interest and Confidentiality forms and no conflicts were raised.
