

# EAGA STRATEGIC PLAN 2021-25

This document should be read in conjunction with the EAGA 2021-25 Memorandum of Understanding (MOU).

### Vision

Melbourne's East is home to healthy, prosperous, environmentally sustainable and resilient zero net emissions communities.

## Mission

EAGA will facilitate the region's transition to zero net emissions by 2030 by delivering innovative climate change mitigation and adaptation projects, influencing policy and programs through advocacy and build the capacity of its members and stakeholders.

# EAGA's Role

EAGA pursues its vision and mission by implementing joint initiatives that provide economies of scale and facilitates initiatives typically beyond the reach of individual councils. By doing so, EAGA supports its members in delivering their respective objectives for a sustainable, resilient, low carbon communities and adds value to each member Council's existing sustainability strategies and environmental management plans.

### **Strategic Framework**

EAGA's Strategic Plan (see TABLE 1) details EAGA's overarching strategic directions, objectives and rolling actions the Alliance will undertake to deliver EAGA's vision and mission. The four year strategic plan includes indicative evaluation criteria and is intended as a public document on the EAGA website.

Each year, EAGA will develop an Annual Implementation Plan (AIP) detailing the specific projects and operational tasks EAGA will undertake to deliver the strategic plan over a 12 month period. The AIP allocates responsibilities, timelines and provides an indication of potential resources (such as external funding opportunities) that may assist in the delivery of each initiative. The AIP is intended as an internal document and will be used as a management tool to inform the annual reporting process.
