Background, objectives and methodology



Background and objectives

The City of Monash is considering making changes to the law allowing outdoor smoking and to the Footpath Trading and Access Policy.

- The proposed new law on outdoor smoke-free areas would enable Council to designate smoke-free areas such as particular parks or streets.
- Under the proposed new Footpath Trading and Access Policy, where an outdoor trading area is in a public area, the trader would be required to make food available for consumption at all times. Smoking would not be allowed in these areas and they would be unable to be used as designated drinking areas.

As part of its commitment to engaging with residents and businesses in its planning and decision-making, Council requires research to understand the views of traders and the community.

The purpose of the research is to **understand residents' and traders' views on the proposed changes.**

Specifically, the research was designed to investigate:

- Overall support or opposition to the new law enabling Council to designate smoke-free areas
- Overall support or opposition to the change to the Footpath Trading and Access Policy
- Residents' anticipated likelihood to change their patronage of local businesses if smoke-free regulations are introduced
- Perceived impact to traders' business if smoke-free regulations are introduced.



Research methodology: Resident surveys

Quantitative Telephone survey

n=400 residents of the City of Monash

- 5 minutes duration.
- Survey quotas on age and gender, and weighting applied at the analysis stage to actual age and gender proportions based on ABS census data.
- The maximum margin of error on the total sample of n=400 is +/-4.9% at the 95% confidence level.
- The City of Monash developed the questionnaire and commissioned JWS Research to administer the survey and conduct analysis and reporting.
- Fieldwork was conducted from 23rd – 27th February 2021.

Quantitative Online survey

n=34 residents of the City of Monash

- The questionnaire was designed and administered by the City of Monash.
- Opt-in sampling method.
- Survey hosted on the City of Monash website and included a question to filter out respondents who indicated they had taken the survey previously.
- The City of Monash subsequently commissioned JWS Research to undertake analysis and reporting of the raw data.
- The maximum margin of error on the total sample of n=34 is +/-16.8% at the 95% confidence level. Results should be viewed as indicative only.
- Fieldwork was conducted from 18th February – 22nd March 2021.

The telephone research was conducted in compliance with AS-ISO 20252.

For the online research, analysis of data was conducted by JWS Research in compliance with AS-ISO 20252.



Research methodology: Trader surveys

Quantitative Telephone survey

n=100 Traders of the City of Monash

- 5 minutes duration.
- List of contact details supplied by the City of Monash.
- The City of Monash developed the questionnaire and commissioned JWS Research to administer the survey and conduct analysis and reporting.
- The maximum margin of error on the total sample of n=100 is approximately +/-9.8% at the 95% confidence level. This is dependent on the total number of traders in the City of Monash.
- Fieldwork was conducted from 12th – 17th March 2021.

Quantitative Online survey

n=8 traders of the City of Monash

- Based on the small number of responses, results should be viewed as indicative only.
- Survey was designed and administered by the City of Monash.
- Opt-in sampling method.
- Survey hosted on the City of Monash website and included a question to filter out any respondents who indicated they had taken the survey previously.
- The City of Monash subsequently commissioned JWS Research to undertake analysis and reporting of the raw data.
- Fieldwork was conducted from 18th February – 22nd March 2021.



Executive summary



Executive summary

Overall community support to change the law and the policy

Among residents of the City of Monash, there is a high level of support for the proposed smoke-free laws (87%). Support for change to the Footpath Trading and Access Policy is also high (79%).

- Smokers, who comprise just 12% of the community, are *significantly less likely* than average to support change to the smoke-free laws (71%) and the Footpath Trading and Access Policy (62%). That said, there remains majority support among smokers for these changes.

Around half of the community anticipates that if the law on outdoor smoking is changed and local street-based trading areas become smoke-free, they would be *more likely* to go for coffee or a drink (52%), go for a meal (51%) or attend events (49%). Less than half of the community (41%) expect that they would be more likely to visit shops or other businesses.

- For most of the remaining people, there would be *no change* to their patronage (4% or less claim they would be *less likely* to undertake each activity).
- The majority of smokers (upwards of three in five smokers) do not expect their habits to change if the proposed changes are implemented.

Traders support changes to law and policy

Among traders, support for the proposed changes to the outdoor smoking law is high (84%). Support for the change to the Footpath Trading and Access Policy is also high (79%).

Most traders do not anticipate the outdoor smoke-free law would affect their business

For the majority of traders (54%), smoking is already forbidden at outdoor seated areas where they operate. Most (53%) say the implementation of smoke-free dining would make no difference to their business.

- Just under a quarter of traders (23%) say it would improve business. A similar number (24%) say it would be worse for their business.

Online (opt-in) survey findings are in line with the telephone surveys

The online surveys allow members of the community who wish to contribute their opinion the opportunity to do so. The findings here are broadly consistent with insights from the telephone surveys. There is majority support for changes to the Footpath Trading and Access Policy. The change has potential to increase patronage (or at least make no difference) to business.



Widespread support among community for new law and change to the Footpath Trading and Access policy




Support for proposed law on smoke-free areas



87% of residents support the proposed new local law on outdoor smoke-free areas.

Support is *significantly* lower among smokers: **71%**

Support for proposed changes to Footpath Trading and Access Policy



79% of residents support the proposed change to the Footpath Trading and Access Policy.

Support is *significantly* lower among smokers: **62%**

Significantly lower than the total at the 95% confidence interval.





Majority of residents visit outdoor cafes on footpath areas


Ever visit outdoor cafés on footpath areas




Majority of residents who took online survey support the new Policy and expect it would increase their patronage






Almost all residents visit outdoor cafes on footpath areas




Widespread support among traders for new law and change to the Footpath Trading and Access policy




Most traders do not anticipate changes to outdoor smoking laws would affect local business


